OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING.

- 1. PROMOTION TIMING:** The Promotion begins on August 29, 2022 at 12:00:00 AM Central Time (“CT”) and ends on August 27, 2023 at 11:59:59 PM CT (“Promotion Period”). The Promotion includes twelve (12) entry periods (each an “Entry Period”) as set forth in the chart below:

Non-winning entries do not carry forward into subsequent Entry Periods. The Administrator's computer is the Promotions' official clock.

2. ELIGIBILITY: The Promotion is offered only to legal residents of the fifty (50) United States, the District of Columbia, Canada (excluding Quebec), Guam, and Puerto Rico who are at least eighteen (18) years of age or the age of majority in their place, province or territory of residence at the time of entry. Employees, officers, directors, representatives, and agents of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Promotion Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All applicable federal, state, provincial, territorial, and local laws and regulations apply. Void in Quebec and where prohibited or restricted by law. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Promotion. For purposes of the Promotion, an entrant's residential address and e-mail address will be the physical address and email address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

3. HOW TO ENTER THE PROMOTION: There are four (4) ways to enter the Promotion:

A. Purchase Method of Entry: During the Promotion Period, an eligible entrant may visit a participating Darden restaurant location and complete a purchase. Upon making a purchase, entrant will receive a receipt with a survey code and promotion URL. Entrant may visit the URL complete and submit a survey. Entrant must then complete and submit the registration form by providing the information requested by Sponsor including, but not limited to: complete first and last name, street address (P.O. Boxes are not permitted), city, state/province/territory, ZIP/Postal Code, daytime phone number, date of birth, survey code, and agree to these Official Rules. Upon completing the survey and registration information entrant will receive one (1) entry into the applicable Entry Period.

B. Free Mail-in Method of Entry: To enter without making a purchase, an entrant may handwrite his/her complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, telephone number, and date of birth (MM/DD/YYYY), on a 3½"x5" card ("Mail-In Entry") and mail it (in an outer mailing envelope) with sufficient postage to Guest Satisfaction Survey Sweepstakes, PO Box 211, Macedon, NY 14502-0211 (. Mail-In Entry is worth one (1) entry.

All Mail-In Entries must be postmarked and received by the dates as set forth in the chart in Section 1. Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, and Mail-In Entries sent in excess of the entry limits set forth below will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries.

C. Scan QR Code: During the Promotion Period, an eligible entrant may visit a participating Darden restaurant location and scan the Promotion QR code provided on Promotional material. Upon scanning the QR code, entrant will be prompted to register for the

Promotion, provide the survey code, and complete the survey. Upon completing the survey, entrant will receive one (1) entry into the applicable Entry Period.

- D. Email Invitation:** During the Promotion Period, an eligible entrant who receives an email invitation may follow the links and instructions in the email to register and complete the survey. Upon completing the survey, entrant will receive one (1) entry into the applicable Entry Period.

Limit: Regardless of the method of participation, an entrant may receive up to ten (10) entries per Entry Period, during the Promotion Period. An entrant will receive no more than the stated number of entries during the Promotion Period. If more than the stated number of entries is received from the same person, telephone number and/or e-mail address on any given day during the Promotion Period, the entries may, at the Sponsor's sole discretion, be disqualified.

- 4. RANDOM DRAWING:** On or about the dates as set forth in the chart in Section 1, Administrator will select the potential winners. There will be five (5) potential winners randomly selected from each Entry Period. Each winner is deemed to be a potential winner, pending verification of the entrant's eligibility and compliance with these Official Rules as determined by Sponsor or Administrator, at their sole and absolute discretion. Canadian residents will be required to correctly answer a timed mathematical skill-testing question as further described in Section 6 before being declared a potential winner.

5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN FLORIDA. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN ORANGE COUNTY, FLORIDA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR PROMOTION ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
